**Refund Rules:** The Schedule of refund of fees will be as follows. If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

| Sr. No. | Percentage of  | Point of time when notice of withdrawal of admission is received in the                        |

|         | Refund of Fees | Higher Educational Institutions (HEI)  |
| (1)     | 100%           | 15 days or more <b>before</b> the formally-notified last date of admission.                    |
| (2)     | 90%            | Less than 15 days <b>before</b> the formally-notified last date of admission.                  |
| (3)     | 80%            | 15 days or less <b>after</b> the formally-notified last date of admission.                     |
| (4)     | 50%            | 30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission. |
| (5)     | 00%            | More than 30 days <b>after</b> formally-notified last date of admission.                       |

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
