#### **Information Handout**

1) Introduction: This Handout gives information about the transfer of admission in 2<sup>nd</sup> year / 3<sup>rd</sup> Year against vacant seats of Bachelor of Architecture (Batch-2023). Transfer of admission, only if vacant seats are available.

# 2) Eligibility:

- Candidate should be passed in all subjects of first year and Second Year (for 3<sup>rd</sup> year B Arch) program
- Candidate should have below mentioned documents / attested copy:
  - (a) B. Arch. First year (Semester 1 and Semester 2 marksheet)
  - (b) B. Arch. Second year (Semester 3 and Semester 4 marksheet)
  - (c) No Objection Certificate from previous college
  - (d) No Objection Certificate from Council Architecture (COA)
  - (e) SSC Marksheet & Passing certificate
  - (f) HSC Marksheet & Passing certificate
  - (g) NATA card
  - (h) Leaving certificate
  - (i) Migration Certificate (for outside Maharashtra state candidate only)
  - (j) Transcript (for IB Board only)
  - (k) AIU Certificate (for IB board only)
  - (I) GAP certificate (if applicable)
  - (m) Medical Fitness Certificate

#### 4) Selection Process:-

- The Merit list will be prepared on the basis of the application data in terms of academic marks at the B. Arch. First year examinations (all semesters) for Second Year B Arch program and Second Year marks for Third Year examination (all semesters) only.
- The selection will be solely based on merit. In this regard, the decision of the NMIMS will be final and undisputable as also shall be binding on all concerned.

## 5) Program Fees:

Fees for Batch-2022-23: Rs. 5,03,000/- per year (for information only)

Fees for the current year will be intimated at the time of admission.
